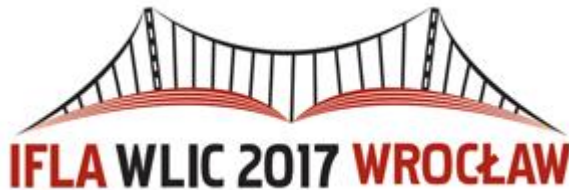
Agenda: The remaining agenda items were accepted and the meeting commenced.

10. IFLA Projects 2016-21: the issue of updating Guidelines for Libraries of Government Departments was discussed as the major project for the next two years. The objective is to focus on 'Chapter 11 - Advocacy' and to tie it in with IFLA's support for the UN Sustainable Development Goals (SDGs). The meeting in Berlin 2017 will provide an opportunity to arrange a 'GLS Guidelines updating workshop'. The aim is to prepare the final updated version to be completed and presented at WLIC in Kuala-Lumpur, Malaysia . Anoja proposed to use Basecamp Platform to promote co-ordination between the working group members. Beacher proposed the drafting of an outline of this work for everyone could contribute. Stephen guided the Committee members and guest contributors on best ways to approach revision of guidelines, drawing on his experience of working with other Sections undertaking similar exercises

Closure of meeting: The Chair thanked the Committee and the guests who had contributed to a full and frank discussion on working together to achieve the objective of revising Government Libraries and Departments guidelines to align it with the UN Sustainable Development Goals.
