Field Definition

This field contains the access point for an authorized form of name for a person associated with the work described by the record.

This field is intended for catalogues that comply with the FRBR model, and is found in a record describing a work of which at least one creator's name is known. In a record describing such an entity, it is mandatory that a creator's name be recorded in a field 500, 510 or 520 according to whether the name is that of a person, a corporate body or a family.
